

Crop Insurance Deadline - April 15

Florida Citrus Mutual and others strongly recommend growers purchase some level of crop insurance by April 15, 2018 - the final date to apply for 2018-2019 coverage. Current policyholders who wish to make changes to their existing coverage also have until the April 15 sales closing date to do so. By purchasing at least catastrophic (CAT) insurance for the 2018-2019 season, you will obtain limited protection in the event of a major disaster.

USDA and Congress are both very keen on crop insurance to offset losses from agricultural disasters, such as Hurricane Irma. It is not known if recipients of relief dollars will have to purchase crop insurance for the next two "available" years and growers who had crop insurance at the time Irma hit will be eligible for greater relief payments than those who did not. Growers should take a hard look at their risk management portfolios prior to the April 15 deadline to determine the amount of coverage needed for their operation.

Grower Round Table & Diaprepes Management, May 15, Wauchula

Peace River Valley Citrus Growers Association and UF IFAS Extension will be conducting a grower round table meeting on May 15, 2018 at the Hardee County Extension Service office, (507 Civic Center Drive, Wauchula) beginning at 8 AM. and with an update on Diaprepes management beginning at 9:30 AM.

The purpose of the round table meeting from is to allow growers to discuss their observations related to HLB, psyllid management, yields and current crop condition. The round table meeting will be followed by a presentation from Dr. Larry Duncan. Dr. Duncan will highlight his trials using parasitic nematodes to control Diaprepes larva in the soil as well as foliar sprays to manage adults in the tree canopy.

The National Agricultural Statistic Service (NASS) will provide the next crop estimate on April 10 and May 10. The March estimate remains unchanged at 45 million boxes for oranges and at 4.65 million boxes of grapefruit.
