

#### Worker Protection Standards – Train-the-Trainer, January 29, 2019, Wauchula

A training session will be conducted from 1:00 PM to 5:00 PM at the Hardee County Extension Service Office, Wauchula on Tuesday, January 29<sup>th</sup>. The session will cover the worker protection standards (WPS) information required under the rule to train employees as pesticide handlers or workers.

If you wish to attend the class to obtain a WPS Training Certificate or for four CEUs, please call the Hardee County Extension Service Office at 863-773-2164 to register. Registration fee is \$10 per person.

If you were trained as a trainer under the WPS rule prior to 2017, you will need to be trained under the new rule that was implemented in late 2016 prior to conducting either 'handler or worker' training sessions unless you have a valid restricted use pesticide license.

### Citrus Grower Roundtable Meeting, January 30, 2019, Arcadia

The Peace River Valley Citrus Growers Association and UF/IFAS Extension will be hosting a citrus grower roundtable discussion on Wednesday, January 30<sup>th</sup> at the DeSoto County

Extension Service Office. The program will begin at 8:00 AM on January 30<sup>th</sup>. The purpose of the roundtable meeting is to allow growers to discuss their HLB and other pest management programs as well as observation of the 2018-19 crop season.

Donuts and juice will be provided. Please come and share what you and your fellow growers are doing and what seems to be working in your groves to enhance tree health and yields.

citrus operations in the State of Sao Paulo. The trip will depart Florida on a Saturday evening and return the following Saturday morning.

I am working on dates and costs for the trip and hope to have that information within the next few weeks. If you would be interested in traveling to Brazil in May or June 2019 to visit citrus operations, please let me know to allow your name to be added to a list to receive information on the trip as it becomes available.

#### Florida Minimum Wage

The minimum wage for Florida workers increased from \$8.25 to \$8.46 per hour effective January 1, 2019. Each year the minimum wage may be adjusted due to the 2004 constitutional amendment in which the state minimum wage is tied to inflation. The federal minimum wage remains at \$7.25. H2A employees have a higher minimum wage based upon program requirements.

### **Proposed New Requirements Related to the Use of Paraquat**

Changes are being proposed for the use requirements for paraquat later in 2019. The major changes include:

- new closed-system packaging designed to prevent transfer or removal of the pesticide except into the application equipment
- new specialized training for certified applicators
- restrict the use of paraquat to allow application only to certified pesticide applicators

With these changes in mind, it would be wise to begin work on getting all applicators trained to obtain their own restricted use pesticide license if they will be applying paraquat. Remember as the proposed rules are implemented it will no longer be allowed for applicators to work under the supervision of a certified applicator when applying paraquat.
