Survey of Interest in Use of the Abscission Agent CMNP--Usage under FDOC's 'Experimental Use Permit' When Issued by EPA

The Florida Department of Citrus (FDOC) has been notified by the Environmental Protection Agency (EPA) that a decision on our Experimental Use Permit (EUP) application should be made by July 14, 2011. This will be coordinated with EUP application and approval by the Florida Department of Agriculture and Consumer Services (FDACS). FDOC needs to confirm the degree of interest of growers, harvesters, researchers, or others, to be a part of this EUP program and experimental level of CMNP utilization.

Use of CMNP under the EUP is projected for the entire 2011-12 fruit season. The FDOC application to EPA requests the permitting of CMNP use on 9,000 acres of processed round oranges (only in Florida and only processed oranges). However, granting of the EUP is at the discretion of EPA and FDACS and they may grant approval for fewer than 9,000 acres. A Temporary Tolerance ('TT') has also been petitioned and must be approved by EPA so treated fruit can enter commercial channels; otherwise any EUP acres would be 'crop destruct'. The TT decision should also be provided by July 14, 2011.

Interested parties (potential 'Cooperators') need to understand that this proposed use of CMNP on Florida citrus is 'experimental'. The product is not being made available for 'commercial' use during the 2011-12 fruit season. During experimental use of this abscission agent, the primary purpose is to learn more about the product use patterns and the gathering and submission of EPA-required data; this EUP data may be used by EPA as part of their review of FDOC's application for 'Full Registration' (e.g., for approval of commercial use). Information related to the industry's use of CMNP, as well as that for EPA requirements , must be recorded and reported at the appropriate times. Contingent upon approval of a TT, fruit harvested with the use of CMNP may enter commercial channels just as fruit harvested without the use of CMNP.

CMNP use will be allowed during the period of harvest of round oranges and will primarily be used in conjunction with Mechanical Harvesting. However, there is a small allowance to use CMNP with traditional manual harvesting to generate data for that use. The CMNP formulation to be used during the 2011-2012 season will be distributed to Cooperators by the FDOC, and its Agent, AgroSource, Inc., provided that the person(s) or company has been qualified as a Cooperator within the EUP program.

Cooperators and their estimated acreage of CMNP use will have to be identified by the FDOC to the EPA and FDACS prior to Cooperator use of CMNP. In addition, under EPA and FDACS requirements for use of the CMNP during the EUP, the Cooperators will also have to agree to collect and submit specific data to the FDOC and its Agent as is required by EPA. As FDOC's Agent, AgroSource is responsible for submission of required data to EPA.

The FDOC will be sponsoring a meeting of all interested parties to discuss the process and details necessary to be qualified as a Cooperator in the program. This meeting will be held at FDOC Headquarters in Bartow (date to be determined). Further information on the use and restrictions on use of CMNP will also be provided. All qualified Cooperators will be required to attend training sessions on the use of CMNP and the necessary data collection required.
