December O.J Break

Our December OJ Break will be held at the UF/IFAS Citrus Research and Education Center, Ben Hill Griffin Auditorium located at 700 Experiment Station Road in Lake Alfred. It will



be held on Thursday, December 3, 2015, beginning at 10:30 a.m.

The OJ Break will be covering citrus cold protection using microsprinklers, critical citrus leaf freezing temperatures and cold protection resources available on the Florida Automated Weather Network (FAWN).

A few years ago a study was done to quantify the effect of microsprinklers under the canopy of mature citrus trees. We will be presenting the results of that particular study. In addition, we will be reviewing critical citrus leaf freezing temperatures and their use in determining when to turn off microsprinkler irrigation systems after a freeze event.

Rick Lusher, Director of FAWN, will be updating us on the cold protection tools and resources available through the FAWN network. There have been a number of additional stations added to FAWN and an expansion of citrus cold protection tools.

There will be lunch after the OJ Break which will mark the start of the CRDF Thermotherapy Field Day, please see the next article for Field Day and lunch registration information. Lunch is part of the Thermotherapy Field Day not the OJ Break.



CRDF Thermotherapy Field Day

If you only want to attend the Thermotherapy Field Day and do not wish to meet at the Center, please follow the Field Day directions located on the attached flyer. We would still need you to preregister. This will insure we have an adequate quantity of printed materials to have available at the field site.

January OJ Break - Field Tour

On January 7, 2016, our OJ Break will be a field tour of the St. Helena and Wheeler rootstock trials. At the St. Helena site, Dr. Jude Grosser will be presenting the latest information on the trial. This will be our fifth year visiting this trial and many of the rootstocks used in the trial have been released to citrus nurseries and are now available to growers. We held off on scheduling the field tour until closer to harvest so you could get an idea on fruit retention.

The second stop will be a cooperative young (trees are two-years old) rootstock trial of Dr. Bill Castle with Wheeler Farms right down the road from St. Helena. In this trial there are additional rootstocks on three scions. I have attached a registration form, along with a map of the stops. We are asking that you meet at the St. Helena site at 10:00 a.m. to begin the tour. After we visit the St. Helena site we can then travel over to Wheeler Farms' site where Dr. Castle will be providing some additional information on the trial. We are ordering boxed lunches for the field day so, make sure you register and make you lunch sandwich selection. Plan to bring a folding chair or sit on your tailgate for lunch. Florida NRCS Announces Signup Cutoff Date for Key Farm Bill Program

State Conservationist Russell Morgan with the USDA-Natural Resources Conservation Service (NRCS) announces December 18, 2015, as the cutoff date for the Environmental Quality Incentives Program (EQIP) sign up for the fiscal year 2016.

EQIP offers financial and technical assistance to install structural and management practices on eligible non-federal lands to address natural resource concerns. Conservation treatment activities for EQIP are carried out in accordance to a conservation plan that is developed with the landowner or manager.

For citrus, the EQIP has been used to provide cost share funding to convert sprinkler or volume gun irrigation systems to efficient low volume irrigation systems. It is also used to upgrade poorly designed low volume systems to become more efficient. Replacing old, leaking poly tubing may also be cost shared. All irrigation systems must meet NRCS specifications after they are replaced or repaired in order to be eligible for payment. Implementing a detailed irrigation water management plan may also be eligible for cost share funding, as well as other practices as needed.

State-wide priorities for EQIP include erosion control, water quality, water quantity, animal / plant health and confined livestock operations. Individual county priorities may vary slightly due to locally established objectives.

Applicants must meet program eligibility requirements. These include meeting the Adjustable Gross Income requirement (less than \$900,000). Applicants must be a farm of record or establish farm records with the Farm Service Agency. Entities that apply must obtain a Dun & Bradstreet Universal Numbering System (DUNS) number and become registered in the Central Contractor Registration (CCR) system.

Agricultural Tax Planning - Less Stress Over Your Federal Tax Filing - Part 1 (Author: Thomas J. Bryant, CPA and Ryan Beasley, CPA).

You would be hard pressed to find someone who enjoys filing his or her federal income tax return or struggling at the last minute searching for documents and information their tax return preparer needs to complete their return. Some time spent early in the process and knowing the information your tax return preparer needs can ease the stress. This article is geared to the cash basis sole proprietor filing a Form 1040 and Schedule F, but also has application to other types of entities. In this article the terms tax return preparers and tax professionals are used interchangeably.

Due to the amount of information contained in this article, we have divided it into two parts. Part 2 will be in the January, 2016 issue of Citrus Notes.

Basic Information and Documents Required

Most CPA firms and legal firms doing tax work will send out Checklists or Organizers to repeat clients at tax return preparation time. A lot of the required information we have listed below will be covered on these forms. Take the time to accurately complete these forms on a timely basis and return them to your return preparer with your supporting information. It will save both you and your tax return preparer time and save you money.

For those using QuickBooks or other accounting software; a Working Trial Balance, Financial Statements, Journal Entries, and a detailed General Ledger for the year should be supplied. For those operating out of a checkbook, furnish Bank Statements for the entire tax year and a detailed spreadsheet of all income and expenses. <u>Always</u> use a separate checking account for your business.

Other Information and Documents Usually Furnished Include:

- Copies of all invoices and any other documents involving the purchase of capital assets during the tax year, such as farm equipment, trucks, autos, and purchases of/ or improvements to real property. Information on asset disposals or trade-ins should also be furnished, plus any leases entered into during the year. Under the new Tangible Property Regulations (TPRs); capital assets are either a separate Unit of Property (UOP) or are grouped into a UOP. You should group your fixed asset invoices into their corresponding units of property. The fixed asset information is also required for the preparation of your Florida County Personal Property Tax Return, if applicable.
- Also under the new TPRs incidental materials and supplies (M&S) may be currently deducted. Non-incidental M&S cannot generally be deducted until used. You should advise your tax return preparer of the procedures or policy you have put in place to make this determination.
- Provide the details of your De minimis Safe Harbor Election (DSHE) policy so that your tax return preparer can make your annual election. Generally most sole proprietors will have used the \$500 (\$2,500 as of January 1, 2016) limit for currently deducting items under their DSHE. Regardless of your elected limit, the determination is based on a per invoice or per item basis if shown on the invoice. Any additional costs such as shipping or installation are also included on the invoice; those costs must also be included in determining if the item(s) fall within the taxpayer's deductible limit. Note: The new \$2,500 limit effective for 2016 may be used for earlier years as the IRS has stated it will not raise upon examination the issue of whether a taxpayer originally qualifying only for the \$500 limit uses the \$2,500

- limit for years 2014 and 2015. You may want to review your capitalized items for the year to obtain the maximum deduction under the DSHE \$2,500 limit. This could be big! If you purchase 10 items for \$2,000 each and they are stated as such on the invoice and all other qualifications are met, you may deduct the entire \$20,000 currently.
- Details of actual expenses incurred for autos and trucks used 50% or more in your farming business. This includes oil and gas, repairs, maintenance, insurance, tolls, etc. Also provide beginning and ending odometer readings for the year for each vehicle. Your preparer may have a choice in deducting either actual expenses or the standard mileage rate (57.5 cents for 2015). If any of your vehicles are also used for personal use, actual paid expenses and a log must be kept supporting the business use.
- All Form W-2's, 1099's, 1098's, K-1's and any other tax related forms that you receive.
- As part of the Obama healthcare law, you should receive a Form 1095-A, 1095-B, or 1095-C if you or anyone in your family had health insurance coverage during all or any part of 2015. Give copies of these forms to your tax return preparer. If you had health insurance for a part of 2015 but did not receive any of the 1095 forms, give your return preparer the details of who was covered and for what period of time. Your return preparer may be required to prepare additional forms and you may be required to pay a penalty if you do not meet any of the exemptions. If you purchased insurance through the Health Insurance Marketplace you may be entitled to a premium tax credit. The Form 1095-C should provide information to determine this.
- Taxpayers that have employees should provide copies of their federal Forms 941,

943, 944 and 940. Also provide a copy of the W-2 Summary and Form W-3. If your tax return preparer has prepared and filed all of the forms for you, he/she will already have copies.

- Amounts paid for meals, entertainment, and refreshments for business meetings or functions must be separately stated from business travel and lodging expenses. Actual receipts must be provided to your tax return preparer for these expenses or a sworn statement that you have these documents.
- Citrus growers should also provide harvesting income and costs, participation interests, patronage dividends, replanting costs, and pre-production costs.
- All details and documents regarding any water or soil conservation expenditures such as land clearing, brush removal, temporary roads, drainage ditches etc. should be provided as special treatment for these expenses is required.
- If your business includes timber, give details on any harvesting income and related expenses, management costs, restoration costs, and replacement costs.
- Amount and date of any estimated federal income tax payments.
- Any changes in your farm operations from the previous years. Any one time or unusual transactions, and any weather related or other damages including insurance reimbursements should be explained and supporting documents submitted.

Any or all of this information may be submitted electronically, on a flash drive or in hard copy. Electronically or on a flash drive would be preferable.

Closer (sulfoxaflor) Cancellation Order Issued by EPA

On November 12, 2015, the EPA issued a cancellation order for Closer (sulfoxaflor). The link below provides more information on that cancellation. The cancellation means that the product can no longer be sold at this time. However, if growers still have this product on hand, they are permitted to apply the product previously purchased according to the label directions on the container. It is unknown at this time when sulfoxaflor may be reregistered.
