



Weather Outlook

Based on the latest El Nino/ Southern Oscillation (ENSO) forecast, conditions have recently transitioned from El Nino to ENSO-neutral conditions. This transition to ENSO- neutral conditions has resulted in an update to National Weather Service's May Atlantic Hurricane Outlook.

The latest hurricane forecast update now indicates that there is the potential for a more active hurricane season than that which was forecasted back in May. The likelihood of an above-normal hurricane season rose from 30% in May to 45% in the updated forecast. The likelihood of a near-normal hurricane season dropped from 40% in May to 35% in the August update. Below-normal activity dropped from 30% to 20%.


FMC CORPORATION & AGNET MEDIA

FMC, IN COLLABORATION WITH AGNET MEDIA, IS NOW OFFERING THE FMC CITRUS AG PRODUCTION SCHOLARSHIP (FMC CAPS) PROGRAM.

The first of its kind, the program awards five generous \$5,000 scholarships to eligible students at the University of Florida and Florida Southern College. The program is now accepting applicants.

FMC CAPS is designed to support Florida citrus production and to support young adults who are pursuing careers in citrus. Eligible students can apply online with a video essay application that addresses a series of industry-specific questions.

Gramoxone Mitigation Activities

The following information is from John Taylor and Zach Langford of Syngenta Crop Protection.

Heading into this fall expect to begin seeing more and more public announcements regarding Paraquat mitigation.

On March 8, 2019, EPA released the Paraquat safety video that all applicators, mixers, and loaders are required to complete once the new labeling goes into effect this fall. We expect to see Syngenta Paraquat products with the new labeling by November 14, 2019.

All applicators, mixers, and loaders are encouraged to begin completing the training now that it is available.

The training EPA approved internet training, once completed, is valid for 3 years from the date of completion.

All applicators, mixers, and loaders should be sent to this site to satisfy the training requirement.

The video is about 30 minutes in length. The link for the training video is below. It requires users to create an account with user name and password.

Additional Information (from EPA)

This additional training requirement is due to accidental ingestion of paraquat resulting in the deaths of individuals over the past 20 years.

In addition to completing the paraquat safety video, all applicators, mixers, and loaders which use paraquat must now also be certified applicators. In Florida, we call certified applicators Restricted Use Pesticide (RUP) license holders.

EPA requires anyone intending to "use paraquat" have a RUP license and complete the paraquat safety training. This "use paraquat" statement would include pre-application activities involving mixing, loading, and applying the pesticide and other pesticide-related activities. These other activities include, but are not limited to transporting or storing opened pesticide containers, cleaning of equipment, and disposing of excess pesticides, spray mix, equipment wash waters, pesticide container, and other paraquat-containing materials.

Non-certified persons working under the direction of a certified applicator are no longer allowed to use paraquat, including mixing, loading, applying the pesticide, and other pesticide-related activities.

The newly revised paraquat labels should be on the product by November 14, 2019. To summarize, as part of the new label applicators, mixers, loaders, and other pesticide-related activities must:

- 1. Complete the EPA approved paraquat safety training video (documentation provided).
- 2. Be a certified pesticide applicator (hold a restricted use pesticide license).
